We're back in 2022, and your safety is our top priority! Following recommendations from Vancouver Coastal Health and Vancouver Park Board, we will be adhering to the following COVID-19 protocols to keep our visitors, volunteers and vendors healthy and safe:

VACCINE PASSPORTS

Following the Vancouver Coastal Health and Vancouver Park Board guidelines and requests from our vendors and partners, we are implementing mandatory COVID-19 vaccination passport checks at the gates for all participants, vendors and visitors over the age of 12. Please have your vaccination passport and government-issued ID (over age 19) ready when entering the venue.

MASKS

Masks are mandatory indoors at all times, with the exception of children under the age of 10.

About Sakura Days Japan Fair

- Sakura Days Japan Fair ("the SDJF") is a family-friendly, two-day Japanese festival held at the spectacular VanDusen Botanical Garden.
- The festival showcases Japanese cultural and performing arts, cuisine and businesses.
- It is presented by the Japan Fair Association of Vancouver ("the JFAV")
 (www.JapanFairVancouver.com) as part of the Vancouver Cherry Blossom Festival (www.vcbf.ca)
 with the support of the VanDusen Botanical Garden (www.vandusengarden.org).
- In 2018, more than 9,400 people attended the event over two days.
- Along with individual vendor booths, Japanese cultural performances and hands-on activities will be featured inside the Visitor Centre and/or in the Garden to promote Japanese culture by introducing cuisine, arts and crafts, business, fashion and/or other such goods and services.
- Visitors who have paid admission to Sakura Days Japan Fair will gain access to all vendor, performance, and Experience Japan areas in and near the Visitor Centre and inside the Garden. Tickets will be sold in advance as well as on the day of the event.

Message from the Japan Fair Association of Vancouver

Food Vendor Fee

• C\$500 for a 10ft x 10ft booth (price is for two days).

Vendor Criteria

- The JFAV will choose vendors that highlight Japanese business and culture and contribute to the better understanding of Japanese culture in Canada.
- Participation in this event, including, but not limited to retail goods and services that are offered by each vendor, is subject to approval by the JFAV.

Vendor Booth Details

- The SDJF 2022 will have approximately from 13 to 15 Food Vendors and approximately from 20 to 30 Selling/Non-selling Vendors.
- The location of all vendor booths at the SDJF will be determined at the discretion of the JFAV and may be inside VanDusen buildings and/or inside the Garden.

Food Vendor Details

Food Vendors will be provided with the following:

- Tented booth approximately 10ft x 10f.
- Hot and cold water hand wash station, approximately 1 station shared by 2 vendors
- Limited electrical power see "Facilities and Services at the SDJF" for more details
- Refrigeration and potable water distribution in keeping with standard health and utility regulations
- One to three 6 ft. by 2.5ft. wooden tables and two chairs (extra tables will be available at an additional cost of \$15 per table)
- Garbage pickup and grey water disposal from the nearest garbage and grey water station

Please note, all vendors must bring their own power bar(s) and additional extension cords if required.

Food Vendors MUST:

- Minimize by all means possible the amount of garbage generated (the goal is for the SDJF to be a zero waste event)
- Use only biodegradable or compostable plates, knives, forks, spoons and containers
- Properly dispose of waste, recyclables, compostable and grey water at the booth
- Ensure that there is enough staff and food preparation ability in order to prepare and sell food to the large number of people expected to attend
- Make all efforts to reduce wait times and optimize the experience for festival attendees
- Comply with all Vancouver Coastal Health guidelines
- Provide all materials and services necessary for booths, including cooking and other equipment, tablecloths, decorations, additional lighting, signage, extension cords, etc. There is no kitchen available onsite for food preparation.
- Purchase individual insurance coverage for this event
- Collect requisite taxes
- Participate for the full two days of Sakura Days Japan Fair 2022
- Have the booth fully set up by 10:30am both days and ready for inspection at any time by Vancouver Coastal Health (set up time starts at 7:00am) on Saturday
- Make sure that the booth is returned to a clean pre-Festival state at the end of the event
- Provide a suitable certified portable fire extinguisher at the booth if any cooking, heating or electrical equipment will be used
- Agree to comply with event rules and treat fair committee members, partners, volunteers with respect and value the purpose of the event
- Understand that failure to comply with any of the above points may result in fines being levied, closure of your booth or any portion of your booth's operation or disqualify you from participating in future JFAV events.

Facilities and Services at the SDJF

• There is a limit to the electricity supply available for each booth (110 V 500-Watt max total). Additional power may be available at a cost of \$150 for each additional 1500 Watt circuit; however, it is subject to availability.

- Please make sure to provide the JFAV with a detailed description of electrical equipment and wattage used during the event. All equipment use requests is subject to approval by the JFAV. Please note, only electrical equipment listed on this application form can be used during the event.
- Washrooms are located in the Visitor Centre and porta potties are near the Cherry Stage and food booth
- Food vendors agree to use the refrigeration and other facilities provided by the JFAV at their own risk and waive all claims against the JFAV and its partners.
- Although security will be onsite from 8:00am to 1:00 am every day, the JFAV will not be responsible in any way for any loss or damage that may be suffered as a result of participating in this event. We recommend vendors take all valuables to a secure place overnight.
- If, in the opinion of the JFAV or any other government, municipal or regulatory body that may genuinely exercise control over the safety of the public, participants or volunteers, conditions exist as a result of weather or other factors that may create potential hazards to the safety of the public, participants, or volunteers, it shall be at the sole discretion of the JFAV to close down an offending booth or booths, or even the entire event if deemed necessary.

Marketing and Promotion

- Due to the unique nature of this event, as well as the variety of activities, we expect that this event will get extensive media coverage. It will be featured in Vancouver Cherry Blossom Festival ("the VCBF") advertising and publicity including numerous community event listings, websites and mailing lists.
- By filling out this application, the vendor grants the JFAV and the VCBF the right to use the vendor's name and photographs, likenesses and biographies to advertise and promote the Event.
- Please be sure to indicate on the application form if you are willing to be interviewed by the media and your preferred language(s) for interviews.

As all food vendors need a Temporary Food Service permit from Vancouver Coastal Health, each food vendor must submit a Temporary Food Service Application to the JFAV. The JFAV Food Vendor Recruiting Manager will have previously informed vendors as to which application form and details are required for this permit. The JFAV will then submit all vendor applications for this festival to Vancouver Coastal Health.
